AFFIDAVIT OF PATRICK KIM

State of Montana County of Gallatin

On this ______ day of <u>December</u>, 2023, <u>Patrick kying Kim</u> appeared before me, an individual known personally to me the person that affixed his/her signature to this document below and being first duly sworn on this oath, hereby deposes and says:

I, Patrick Kyung Kim, am over the age of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.

Please note, all journal entries in this document are from October and November 2023.

- I am a copywriter currently employed with an agency whose main client is Uber/Uber Eats. I graduated from University of California, Santa Barbara in 2013 with a degree in East Asian Studies.
- 2. It is likely the targeting started well before 2021, but the most stark and unambiguous evidence of targeting started that year. Please see the following journal entries from October and November 2023 which recall key events that demonstrate this evidence:

10/31: [In] 2021[,] gangstalking was everywhere I went [in] Honolulu—people [were] watching me [and] referencing things in my life [that were unnatural for them to have knowledge of, and honking throughout the day in front of my apartment—a known gangstalking practice—it seems in response to real-time brain data from remote neural monitoring (RNM). Honking activity also happened for months while in San Francisco in response to RNM.] I had been experiencing nausea. Marijuana had never made me feel this way before [I was not drinking or taking anything that could have caused it]. I guessed [then] it was device radiation and because I was living merely a few floors below a cell tower deployed on [an adjacent] building. I remember saying to a friend in April that I believed the cell tower was affecting me negatively, that I wanted to get out of my place. I remember him saying "yeah, it's probably zapping yo[u]." I came across a video from WION which talked about Havana Syndrome, and I remember thinking [...] this is could be what is causing that sickness, but why would anyone do that to me, I don't work for the State Department-it must be China, [...] the United States wouldn't do that to me[,] would they? I remember being very apprehensive about watching the video, because some of the AI content recommendations from YouTube were very adversarial, even sadistically so (i.e. there was a [feeling] they would attack me [again] during the video), [YouTube] did not even try to hide its ill intent [while suggesting videos]. Low and behold, after I started watching it and reached the part with [...] animated radio waves and [the] news presenter talking poignantly about weaponized frequency [...], I felt more nauseous (same type of nausea experience as I had previously[,] only more intense) than ever before[,] plus I became dizzy, which to my recollection was the first time this had happened. It was overt, as if this unknown adversarial actor wanted me to know what was going on. I immediately turned off my phone without finishing the video and went to the side of the flat furthest away from the cell tower.

11/17: I remember[ed] thinking [in 2021 while] in Hawaii [that] one of the many benefits of swimming in the ocean is that the EMF can't get you there [though I had not researched EMF shielding at the time]. I think I said this on a few occasions [to others]. In particular, [I remember feeling that] diving beneath the surface level so the head is submerged delivers maximum benefit. Low and behold, [I learn this year that] the [number one] way for TIs [Targeted Individuals] to shield themselves from microwaves is water shielding—water pillows and water bags, etc. [Water] offers the best protection as has been found so far. [...] My instinct is always to get as far away from [cell towers] as possible.

11/2: [I remember that] earlier this April or March, I kept hearing "Kurzweil." This was before I knew anything about his speaking on transhumanism[:] "Computer can make a copy of me, I won't even know they scanned my brain from inside, [...] capture every detail of my synapses and neurotransmitters and create a virtual Ray Kurzweil [...] and it will be indistinguishable, he will pass a Ray Kurzweil turning test." [Before this summer] I just thought he was someone who invented IE [Internet Explorer] or something. [...] I had no idea [this name] had so much relevance [to the transhumanist technologies I am being experiment on with].

11/20: [I remembered that,] [in] early 2022[,] when in Brazil, I often left the house because that is where my computer was, and I attributed the nauseous feeling to proximity to the computer. I was aware of the Havana Syndrome [causing it], [and] afraid that it was damaging my brain, possibly as a consequence of my avoiding the vaccine. I thought it would help to get away from my laptop and so I walked all over the city by myself. It did indeed seem to help me escape it. I mostly had to take my phone with me[,] but tried to keep it off or on airplane mode. I remember being very reluctant to stay at home for this reason, and apparently that was more important to me than avoiding danger outside [on the street]. [On the subject of dangerous situations...] it is curiously obvious how people can stalk [every detail of my life] and somehow this does not jeopardize my bank card numbers, or [S]ocial [Security] number. So it is obvious that to enable this [...] propagandistic [... content generated from gangstalking], [law enforcement] have [been involved.] Identity theft is otherwise a big problem for [anyone.] Also, police always show up just in time when there is trouble

3. Directed energy weapon (DEW) effects:

10/18 at 2:35-2:40 pm: [I] was working on my evidence compilation article, and pointing [out] (out loud) that everyone who has thus far [challenged] me has only been able to do so on terms which refuse to engage with fact. [...] Immediately after making this point, and in fact right now, I [am] tast[ing] the distinct [foreign] metallic taste in my mouth which is indicative of [a] concussion. The heater in the basement made noise to confirm the significance of what had transpired. Five of these attacks occurred last week at more serious levels—serious damage [was] sustained. [I had] very bad insomnia—[and] resorted to med[ication]s [because these brain attacks made me especially concerned about brain health].

10/18: [I] left the house after [a] DEW attack [caused a] metallic taste of brain [fluid] in my mouth [and] went to [...] read [outside]. [The] taste still lingered or [I was] attacked again while

explaining something [I left the house because it is not a good idea to look at screens after a concussion, medically speaking].

10/18 (cont.): [I] experienced [unusual] difficulty with cognition and didn't feel [as] sharp after DEWs today.

10/20 at 3:35 pm: [I was] browsing [X, formerly] Twitter and saw a post by some guy [on someone else's page] who did alternative military events reporting, esp[ecially] in Ukr[aine]. [I] used to look at his page for info about [the nature] of modern war[,] but [I] did not end up looking at this tweet [this time]. [I] scrolled past it, but felt [an] immediate attack on the brain. [I experienced] pain [plus the] tinge of brain fluids entering [my] mouth. [The] refrigerator also ma[d]e a noise at the same time. This makes 10 times in the past 11 days I was severely microwaved such that I could taste the brain damage. [At] 3:40 [pm the] refrigerator ma[de] a noise again, confirming significance of their intent to punish me for "wrongthink[,]" [even though I had not even stopped to check the content in the post.]

10/27: [I] was severely attacked by microwave brain melting—[I] tasted brain matter (first metallic, then blood-like)[.]

10/28: [I sustained] slight nausea [and] vicious V2K while taking legal notes[,] [which will be used to write the article with targeting evidence]. [... A] funny taste [occurred] in [the] back of [my] mouth, [but it was] greatly subdued compared to [the] sensation of brain-flavored vapor [which deposited on my] tongue just about all day yesterday.

10/28 (cont.): Today's earlier unconventionally-acquired brain injury seems severe—[and I sense that my] cognition has suffered. The same distinctively sharp metallic and blood[-like] taste rushed to my tongue for the 12th time [this month]. This taste is unmistakable. It is unlike anything I have ever tasted[,] ever. It has only occurred recently, starting this summer, when the attacks first began [though it was not until I started to work on the article that it happened to me frequently, at a rate exceeding 1-2 times a month]. Nothing else has the taste of brain fluid [or fresh damage to the brain]. Never has this taste occurred to me in so sharp and distinctive a fashion, all coming at once. [Nor] I have never felt the persistence of this taste for so long before[,] following the onrush when it first hits. There is no reason the taste of blood and brain fluid should be dripping down from the back of the roof of my mouth. [...] I am still tasting it almost 6 hours later. The taste is still sharp and distinctive, but it comes on more gradually and less poignantly than when it first happen[ed]. I am consistently finding cognition much more difficult than usual. I keep forgetting what I am saying in ways that would not have happened at the beginning of this month [prior to attacks]. [It's] happened twelve times this October [so far]. 10/28 at 10:00 pm: [I] experienced the unmistakable taste of blood in my mouth again. [It] did not rush in such a great quantity so as to distinguish itself as [an entirely] fresh attack. [...] It was borderline enough that it could have been healing or waste removal from the earlier attack[—which I recorded as one of the 12 attacks from this month—]so I hope that [a taste from the healing process] is what it was. I don't have enough money or insurance to get the [extent of the] damage checked. [However,] cognitive difficulties [were] observed, [such as it was] very strange to misspell [attack above in this entry][;] [that was a] very strange [s]pelling error.

10/31: [I] experienced a steady metallic taste in my mouth since around 4:30 pm, when I had last looked at [X, formerly] Twitter. [I had] never experienced this pronounced[,] sharply metallic

taste, [as] this had [happened before] as a steady stream, but this taste is sharper and ever-present on the tip of my tongue rather than dripping down from the back, near the canals that go to the nose. It remained on the tip, so it seemed maybe I could be tasting some radiation or something like brain healing fluids since I ate salmon. But at 10:50 [pm,] I experienced the distinct taste of blood ([the] metallic sensation [was also] still there). At first, though blood is rarely tasted—only during an extreme attack—I did not believe it should be counted amongst the 12 other brainmelting episodes that happened this month. But I spoke out loud and could hear in my voice the deeper, more guttural sounds I get after a concussion—[a distinct] change in [my] voice. I had not expected to hear my voice like this, which is another [biomarker] indication I can trace back to other concussions. That was the 13th confirmed attack this month.

11/1 at 8:25 pm: The difference in the taste in my mouth when I got up—absolutely nothing—and the taste in my mouth after I start[ed] looking at Twitter is *stark* and *unambiguous*. [The taste] subsided for a while but is now back in force after I spent time looking at and gathering great sources on the psychiatric cover up of civilian targeting. This is an obvious brain damage attack; a heinous war crime. [There were] 14 or more attacks in 30 days or less. [My mouth] tasted like [part of] a penny for whole spells of time today. [This taste only occurs with such attacks.] Other days when attacks have been more sudden and intense over shorter periods of time[,] it has tasted like a whole penny on my tongue. [I] also experienced a momentary blood taste, [but] not quite as strong as the one which came last.

11/2: When I woke up in the middle of the night [this morning while it was still dark], [and found] the roof of my mouth was crusted with the vaporized brain fluid from them microwaving me. It was a bit cakey and sticky for my tongue. This has only happened twice in my entire life—once this morning and once about 29 days ago [during the night after I had 3 such attacks in one day]. The taste was very much the same as the brain fluid previously described. [...] The 14 devastating brain-melting episodes that occurred in the past 30 days began when I watched a

day after these 3 attacks, I had the worst vision distortion I have ever experienced after just 10 minutes of looking at a computer screen, which is known to be a strain on the brain during concussion events. After looking at a block of white text against a black screen for a minute or so, I felt dizziness, then looked away from the screen only to realize everywhere I looked was distorted by a striped light resembling the lines of text, only much more blurred. I had to excuse myself from work that day since simply looking at the screen was causing this extreme health issue.]

11/2 around 6:30 pm: [The] metallic taste occurred again today while I was working on the article ([it] went away while I was at the gym). I said "ban TikTok" and sensed it again. I had just [returned] home when it happened again.

11/2 at 7:41 pm: [I] continued work on the article [and the] metallic taste returned and is still present[.]

11/10 at 12:29 pm: [I] experienced a nausea attack [from a] DEW. Dry heaving [followed]. [It] occurred after [I was] composing Tweets (around 15 minutes later). Enough time elapsed to enable plausible deniability [to be used as a] cover up excuse [for this attack].

11/10 (cont.): Also while working on the Bryan Kofron testimony, I got another microwave attack that gave me a sharp taste of blood in my mouth. That make[s] 15 total while composing this article. It happened in the shower.

11/13: As I am writing this, I am suffering from another concussion [...].

4. Voice-to-Skull (V2K) and synthetic telepathy malfeasance:

10/21: I have often experienced that in the morning I am subject to hearing an extremely inconvenient song in my head. It seems to be implanted while I am sleeping, because no matter how disgusting it is [in context], I cannot get it out. It makes its way into my conscious without warning, [first thing after I get up], and in the morning I have less whereabouts to stop it.

their own fabricated narrative]. This time, I could easily identify what had happened as a desperate attack on my reputation—[I] was working on [my article] evidence [...] consolidation. [It] very unambiguously would not have happened naturally, [as it would have represented a] clear break from [my] natural personality [had I not know where it came from]. 10/28 (cont.): Because I covered significant evidence on my situation of remote torture today, the V2K was exceptionally aggressive in trying to discredit me. [...] It tries to take advantage of any situation which could look bad for me. [Today] it was non-stop, all-day psychological torture.

10/30: [I] heard many racial slurs last night, and many today. [I] thought about writing about it in my journal [as a measure to counteract these things] and [paradoxically] heard the racial slurs repeated. [Having] just watched [a] video of [an] ex-MI5 [and MI6 whistleblower] explaining these weapons and how blackmail is the most important function of intelligence agencies[,] I believe I am being used as a blackmail advertisement that operates in a new way by artificially generating the content of a defamation.

11/1: [I] experienced severe entrainment[,] hypnosis, [and] synthetic V2K after waking up. 11/1 at 7:47 pm: Heard several defamation attacks beamed into my head, [and the] heater starts making *loud* noise.

11/7: [I strongly feel that] I am being framed for the purpose of taking away our rights—
[specifically through] FISA 702. [I] have been hearing things like "Al Jazeera" and "
for weeks now. "Al Jazeera" began before the [current IsraelPalestine conflict], and the [latter] began after [not only is it out of nowhere because I had not remembered such a thing for years and years, but this example of propagandistic and defamatory V2K is also completely out of context.] [...] The latter is something where I was 16 years old (16 years ago),
in the [satirical] style of Borat. [The V2K is] completely framing me [I feel in order] to renew [FISA Section] 702. Much of the shocking V2K doesn't have anything to do with me. I do not see how it is possible I would naturally be hearing these things in my head if it were not for the intentional framing of me for political purposes.

11/8: V2K has been crazy today, possibly the most aggressive [defamation] campaign experienced to date. It involves names from high school chiefly. I started on [a] walk just now This was 100% a blindside and heard the name of an where I was so shocked at hearing it that I knew there was no mistaking [it] for V2K/synthetic telepathy. There is an even lower probability I would hear this while sitting down to start my work[. It would be lower] than 0.00001%, I feel. I just don't hear things in this way when I am in my own mind. I know it was a defamation attack, [and meant to be] a rug pull [and a] retaliation on whistleblowers. There is virtually no chance this occurred to me naturally[;] knowing myself[,] I sensed and caught it right away. I have no doubts about this and the intent is obvious. 11/8 at 2:45 pm; [I heard appalling V2K but] I was talking about my work, nothing this specific, about which I have no concern or ever think about, at least have not thought about except incidentally, could occur to speak itself to me so clearly except [through] artificial introduction. 11/8 at 6:28 pm: I was working on my [article]. I hear " [and] anticipate it is building narrative on me [in relation to the names I have been inopportunely, inexplicably hearing]. [This word had] zero relation whatsoever to reality [which makes me wonder, is the] psyop detaching itself from me completely, [in an] act of desperation [triggered by how I am exposing the remote neural abuse in the article]? [It is no longer concerned with trying to conceal its manipulations from me.] Who knows what else they might do. In my life before gangstalking, I almost never thought about HS [high school].

11/8 at 9:50 pm: [I am] hearing more inexplicable assaults via V2K. I would not be able to understand how they [these words] got in my head otherwise.

Content Alignment proving AI management of V2K/synthetic telepathy, along with manipulation of urges (i.e. "listen to this song now") or other mental phenomena

10/19: [I] was reading a post on Twitter about [the] WEF, plans to incubate humans out[side] of womb[s,] [and the] desire [of] globalists to prevent humans from naturally breeding anymore. [I] thought to myself "Mustafa Monde" (Brave New World). [I] clicked on the link and came across quotes from "Mustafa Suleyman[.]" Mustafa Suleyman is [a] co-founder and former head of applied AI at Google Deepmind. [Harari of the WEF says AI will be] "the end of humandominated history[.]" [This seems like AI-powered content alignment because] Suleyman was an Ottoman sultan, [and] the Ottoman empire spanned [continents and ethnic or] national boundaries. [Very seldom do I come across a "Mustafa"; it is not likely that I would hear this name right before opening content that also mentions it. Brave New World is not only directly related to the subject of incubating humans, but to the ideas of global governance, genetic engineering. and technocracy. I had never heard of Mustafa Suleyman before.] [The video's cover photo] also contained [an] image of people wearing "101" prisoner clothing [a number that has consistently had significance for RNM stalking]:



10/21: [I] smoked [marijuana], drank 3.5 beers[,] [and] ate some [marijuana] gummies [to] tr[y] sleeping with no meds. [I] was attacked by the most appalling thoughts imaginable, [and] counted at least 7 times when the words could 100% not have come from myself ["Know thyself"]. [The] language [was] too disturbing to record.

10/25: [I] was watching the Joe Rogan interview with Graham Hancock when they were talking about parallels between [the] Taurus constellation and [a] cave painting of [a] bull, [and] I remembered I wanted to look up [the constellation] Pleiades. As soon as I pulled up an image of the constellation, they mentioned "Pleiades" on [the] show. It seemed like artificial alignment, [as the] statistical probability [of this being so precisely aligned is] quite low, [and] I had not thought about [the Pleiades] for a while. [... The] precise timing seems to be [more than just a] coincidence. [I have a screenshot of a Pleiades constellation image taken on 10/25/2023.]

10/26: [An example of likely hyper game theory AI influence would be] when I saw a poster of a high school classmate speaker on a spontaneous trip to MSU [Montana State University][. I] had felt I absolutely had to leave the house that day [because I had a feeling something bad was going to happen with regard to my V2K

and I had heard there was a fair on a similar holiday. I feel that my memory of the key detail that the holiday on which the fair was held is in the spring was suppressed through EDOM so that I could be guided towards seeing this poster of . There was no fair since the fair takes place in the spring, but a hyper game theory supercomputer could have predicted that I would end up at the indigenous peoples' building where I saw the poster. Knowing my habits, it would know that I would be curious to take a look around the building, especially since I had come all the way out to MSU only to realize the fair is in the spring.] There are far too many coincidences in my life for these things not to be statistically significant.

11/2: Around October 31st to November 1st, I had thoughts about "fiat currency" and "fractional reserve banking." [...] I also had thoughts about how this applies to my situation, with a portion of the content people are consuming about me as they stalk being real, but much of it being fabricated, inflated[, and] printed out of thin air. The next day, I looked at the news to see "They're blowing up the dollar on purpose. Prepare yourselves" and things like "George Soros is famous for shorting the pound." I then felt that maybe those thoughts weren't mine, possibly, and that [with] these sort of things where alignment happens [...,] I [may be] being framed somehow as a scapegoat for things [even though they may be] obviously unrelated to me.

11/10 at 12:55: I very stupidly left the door open while the dog is home. He could have wandered off but [did not until I rushed down to see]. The computer let me [... hear] "[dog's name redacted]" [and] I rushed downstairs right at the moment he was about to wander outside. [It was] not just my instinct [involved]—it can do [such things] on occasion, but this is statistically significant in observation of all else that is going on. I do not think I would have been so oblivious to this danger if my instinct was this engaged. If I was in such a state, I would have realized earlier what was going on, and shut the door *long ago*. [I have since calculated that, because the door was open for at least 2 hours—if not 3—while the dog could have walked out, and that I stopped the dog right as he was about to cross the threshold, there is around a 0.000139 to 0.004167 probability of this happening without the help of V2K or other technology.]

11/30 at 9:50 pm: [I] was working on [a] copywriting project in which I wrote the words "on your merry way." Minutes later, I also hear [these very words] in a song. This happens often with song lyrics pairing uncannily to things I am doing or content I am viewing, but usually [with more much statistically significant] precise timing [that is not easily explained by coincidence].

6. Gangstalking and remote neural monitoring (RNM) invasion of privacy:

10/21: [I] felt stalked at my reading spot [by individuals loudly seeming to reference content from my RNM]. [...] This felt very suspicious and poorly disguised.

11/4: [I encountered] gangstalking [and] obvious references to my brain being melt on the way to hike. [A lady was mocking the phenomenon where my brain is attacked with DEWs. It was obviously and poisonously aimed at me—an unambiguous example of gangstalking.]

7. Feedback noises from appliances (US Patent 5491463A) and head clicks:

10/17: As with every day, V2K is maximally appalling, and everywhere I go the appliances and infrastructure responds to what I am hearing to try and reinforce [it... and] create [conditioning] effects [which] ingrain those things into my mind. Not only was it coming from the appliances in the house, it was the generators outside the food bank as well. [My fridge in San Francisco also made noise at me in the same exact fashion of giving feedback to remote neural monitoring.] 10/17 (cont.): I thought to myself this [program] is tearing me down, destroying my life in every which way, and at that moment I had painfully acute heart palpitations *and* a simultaneous head click which struck viciously and loudly. The timing was absolutely simultaneous—it was [one hundred percent] AI [managed]. Another "light" head click occurred when I recorded this [to gaslight or punish me].

10/18: [...] Regular head clicks [harassed me] throughout the day.

10/20 at 10:30 am: [I heard the] lyrics "tried to change the nation," [and] some kind of emotional response surfaced, [after which the] refrigerator ma[de] noise [in precision timing].

10/20 at 3:42 pm: [I had] severe ringing in [the] left ear (tinnitus) [after the DEW attack minutes earlier]. [I] was just thinking to myself about how I have more evidence than I can possibly synthesize into one article, and the water heater, then fridge start making noise[.]

10/23: [I] just thought to myself, "[this] psyop wan[ts] [to] destroy me" and water heater starts making [a very] *loud* noise. When I decided to write it down, I got a vicious head click. [The] refrigerator [is] now making noise [too].

<u>Date unknown:</u> I just heard "...make it difficult for yourself" [presumably V2K,] and the refrigerator started making a noise.

. I believe sounds are exploited

to create a state of consciousness where I expect something bad to happen [i.e. conditioning]. In anticipation of water heater, refrigerator noises, I [may] have [increased] "intrusive, unwanted thoughts"—which are not normal.

10/25 at 4:51 pm: [I] received around 5 head clicks in the past hour alone. Head clicks work in conjunction with V2K [or] synthetic telepathy to create psychological impressions which [seem intended to] detract from my knowledge of the external origins of interference. It is like a tag team where they hit you with one thing and another to exacerbate damage from the attack.

10/26: [While] walk[ing] to [the] food bank and back, [I] sustained around 15 head clicks within a 1-hour period. Each occasion was over something very trivial. They have no qualms about violating human rights, no matter how trivial the occasion[, it's] outrageous.

10/26 (cont.): [I] was deciding what [food] I was able to share , [and the] refrigerators and water heater made noise. [The] water heater distinctively began making noise again while I wrote down the first sentence, while I was choosing my words. It also seems to make noises [for] even the slightest emotional response. [...] The refrigerator and water heater are hyperactive in responding to the slightest emotion which could be cause for defamation. [There are] hyperactive response[s] even to what is clearly its own manipulation [belonging to the apparatus of which it is a part of]. [...] The attacks by fridges and water heater are extremely stark and shamelessly adversarial. I could be walking by it and it will spring a surprise attack to amplify the unsettling psychological effects of appliances in your residence attacking you [the nature of their presence].

10/31: [I] received a head click for choosing a song—and being happy about my music choice.

11/1: [... A] head click occurred when I decided to put on my cross, a routine task. [The] degree of absurdity [is] likely attributable to article I am writing.

11/1 at 7:47 pm: [I] heard several defamation attacks beamed into my head, [and the] heater starts making *loud* noise.

11/1 at 8:25 pm: While [...] watch[ing] a move (2001: A Space Odyssey), I received a number of head clicks for completely inane things.

11/5 at 9:58 pm: [While] revising [the] article, [I] read "an AI which was fed data from a disturbing subreddit [could] only think of death and destruction." The fridge downstairs made its most noticeable variety of sound. [The intent to threaten and intimidate me while I am writing about human rights abuse is obvious.] [I also] felt [a] slight metallic taste in [my] mouth while writing this down.

11/6: [There is] lots of alignment with [appliance] noise [as feedback to what I am] working [on,] browsing[, or] writing.

11/6 at 12:01 pm: [The] water heater makes noise after I put on the cross[...]. Earlier [I] received a head click while exercising in plank and the cross fell out [of my shirt] into [my] field of vision.

11/7: Head clicks have occurred around 10 times today, in around 3 hours. [This] happens mostly during conscious thoughts [both natural and synthetic]. [There is the] definite sense it is punishing me for my thoughts [... or trying to interrupt them]. However, on other days it also punishes me for artificially-induced thoughts or telepathy, so as to create maximum confusion.

11/8: Head clicks [are] vicious, aggressive, [and] almost painful [in] how discomforting they are. 11/8 at 9:50 pm: [I] got a head click for yawning, among other trivial, functional activities today. [It would seem I am] punished for existing [when I go against the aims of the psyop fashioned out of my life by intrusive neurotechnologies].

11/9 at 11:45 am: [I] got a head click while biking through the park and thinking about a title for the ebook [which was,] "Targeting: A Human Rights Disaster." [I] got another head click while thinking about writing [this event] down. A third head click [occurred] while thinking about what they are doing to me while back at home. [This all occurred in the] space of 5-10 minutes. 11/9 at 2:56 pm: [I got a] head click for writing [down notes about targeting]. [Head clicks are clearly adversarial and meant to harass you, especially at vulnerable moments.] 11/9 at 3:58 pm: [I am] writing a transition, reading evidence, [and] thinking of how to write, [but] progress [has] slowed[.] [At this moment, I sustained a] head click (3:59 pm). [While] listening to miscellaneous details of MK-Ultra [and] cover ups [of illegal government activities], [I] got a head click . [I am] struggling with fitting in the information and [the] "no need to take it from me approach" [which involves] too many quotes. [I am thinking and am] still undecided about [the] approach, [during which time it] gives me a head click.

11/9 at 4:36 pm: I read "evil employees in government entities," [and the] water boiler [or heater] makes [a] loud noise.

11/9 (cont.): [I] thought "I need a break"—[and sustained a] head click. [I suffered] another while writing this down.

11/9 (cont.): [The] water heater made noise at [the following thoughts]: "it's doing this to emotionally condition people in a certain way while I am providing extremely important evidence[,]" "I did not say that[,]" and other things-[these are] intimidation [and] conditioning tactics. [The] water heater [is] extremely active in response to V2K—[ostensibly for purposes of] emotional programming and conditioning. [I] heard "rotten egg," [and it] starts making noise again. If I hear things like "rabbit hole" [and other emotionally charged language related to smear tactics,] then the refrigerator will make a lot of noise. [It is] very obvious [in its] timing. I said it's "a Nazi criminal refrigerator", [and] it also ma[de] a noise. The problem with it making noise at "rabbit hole" is I am working with loads of evidence here. [There is] mountains of it[,] so the refrigerator is trying to gaslight me or disturb me in my home environment. It's all incredibly illegal and clearly adversarial. The water heater basically makes noise whenever the V2K/synthetical telepathy frames me. This is exactly what's happening, dozens of times a day[.] 11/9 (cont.): I think the water heater [and fridges] are also trying to condition me to make me aware of the [false] narratives the same apparatus is generating about me. Another example just minutes later: I hear "disaster" and it starts making noise-even though it knows fully well that the apparatus controlling it is the [...] one causing the damage. This shows how its function is [in] propaganda. People are fooled into believing this [synthetic V2K information], [and] it wants to make it more realistic for them by gaslighting me all day, which it is doing again right now-[I think the] unusual amount of noise today likely has to do with people waking up. It

normally stops making noise right when I make my point—[when I am] talking back or journaling about its crimes against me—another indication it is trying to psychologically condition me by means of *environmental feedback*, gaslighting [... through] the deep, rumbling noise it makes under the house [which] affects you at a subliminal level. It emotionally conditions you in ways you absolutely cannot stop[,] since it functions below the conscious level. It stops making noise when I make my point [...] to take the focus away from the truth [and] slowly and gradually undermine [my] will power to fight back. It started making noise again while [I was] writing the last sentence. I imagine this is to [interrupt] me so that I cannot normally think in peace.

11/10 at 12:36: [I] thought to myself "deterministic [...] environment" and the water boiler [heater] made a heavy, low rumble. Even at a low mechanical noise level, the reverberations can be felt throughout the old, wooden house.

11/10 at 11:03: [I am] getting writer's block [and the] fridge makes noise to psychologically attack me [during moments of vulnerability when it is very important to have peace and quiet in order to find creative solutions]. [...] The fridge and water heater start making loud noise[s in response to V2K defamation attacks].

11/11: Head clicks [are] aggressive, [and] vicious. [I] tried to distract myself with things that are almost meaningless [such as] "bumble rap" [and sustained an] instant[,] super-loud head click. [It is] like getting walloped on the head with an electric fly swatter—but with not much surface area.

11/11 at 10:11 am: [I] said to myself "law enforcement privilege illegitimate" [and then there was a] head click and massive water heater noises [that] instantly went off.
11/11 at 2:00 pm:

[It] wasn't going to be what I wrote anyway, but it does not care about [the truth], it only cares about attacking me as aggressively as possible.

11/13: [I] was thinking about having proof that this whole thing is a scam, and the thing [AI-brain interface] head clicks me. Feedback mechanisms [such as] the fridges, water boiler, [and] head clicks are still very aggressive, causing an environment of distress[,] stress[, and] anxiety in the house.

11/20 at 10:36 am: [I was] head clicked while reading a journal entry.

11/20 at 10:44 am: Another head click [occurred] while [I was] in a moment of indecision about what to do with the rest of my day. This head click apparatus assumes you should function like a robot.

11/20 at 9:44: [I] was head clicked for writing [the entry for 10/18

e] down, [and] was head clicked again for noting [the head click] had happened out loud. [The] same [thing] happened while [I was] transferring the above journal notes [from 10/18 and before] [on]to this document earlier today. An especially large number of head clicks happened today. [They were] extremely vexing and intrusive.

11/20 (cont.): [I] experienced a head click immediately after writing the [10/18 journal entry about "didn't feel [as] sharp after DEWs"] and deciding whether I wanted to include the next sentence. [I] decided it was not as relevant and received a head click that even reached a certain pain threshold in my head, in addition to being vexing and absurdly intrusive.

- 11/20 at 10:32 pm: [I] received [a] head click while writing the [...] journal entry ["felt stalked at my reading spot" on 10/21]. It seems to attack me while I am in a moment of indecision, perhaps to make me feel more on-the-spot and stress me out while carrying out activities that could lead to my freedom. [Head clicks occur almost every day daily, but increased during the 11-day period I was working on this document.]
- 11/21 at 10:12 am: [I] heard V2K which I objected to in the extreme, but they are trying to make it seem like it is coming from me. I explained why I object to it, [and] the heater in my room made a significant noise, even though I [had] turned it off already.
- 11/22: [I] heard "you have nothing to fear" and got the maximum strength head click. Head clicks happened around 20-30 times this evening. In one hour there must have been 25 alone.
- 11/24: The [wall] heaters in my room [are] currently gloating me over [my noting an experience of a very synthetic dream] through clicking noises [...], though I have already turned off the hea[t]. While writing this, the power cord for my monitor and computer disconnects without any physical event which could have caused it. A patent exists for sending data down power lines (US Patent 5491463A).
- 11/30 at 10:56: The heater in my room is making noises though I did not turn it on.
 - 8. Hacking of my computer, browsers, as well as Substack, YouTube, and X accounts:
- 10/22: Clicks register all across the screen [but YouTube] does not want me to mute a video. [I] tried clicking [mute] 10+ times. [However,] pause works...
- 10/23: YouTube on Brave Browser still doesn't work. [It] won't play a single video even though the internet connection is fine. YouTube works on Firefox, but won't sign me in. [These are] very obvious DNS attacks[.] [A video works then] pauses buffering as soon as I point out how biased the media coverage is [...] Rumble is also not working so well. [The] video suddenly loaded once I began writing this down.
- 10/23 (cont.): Videos would not load again, falsely claiming I am without internet service. [I] switched to Firefox, [and] got the worst, clunkiest quality I have ever seen on YouTube.

 10/23 (cont.): Again, [YouTube] refuses to load. [The video I am trying to watch] stops at 1:01. I say "c'mon man[,]" and video loads instantly, [with] plenty of buffering too. [From these seemingly intended service errors, it feels like it wants me to play along with its narrative.]

 10/23 at 11 pm: YouTube still doesn't work [and] won't play any of the videos on my playlists.

 [It] then plays a video 1 hour and 01 minutes long. [I] not fee[l] like [is] a coincidence.
- 11/1 at 3:39 pm: X [formerly Twitter] would not let me 'like' a post about wrongfully-framed service members who lost their jobs.

11/2: I believe [X, formerly Twitter] is currently suppressing my [reach]. Yesterday, [X] tried to stop me from 'liking' a post. On May 28th, I had to try around ~25 times to post something about V2K. [I] posted today on [X] [with evidence] debunking [the] malpractice diagnosis excuse [to suppress evidence about targeting]. [My post] only reached 13 [users]. [I am] not sure if I might be getting shadow banned, because posts used to reach at least 25-30 in the first day, even without retweets.

Date unknown (between 11/2 and 11/5) at 1:51 pm: [A] startling number of typing errors [occur] while working on [a] live document—does this have more to do with [my] keyboard, [or the] live webpage [...?] [In retrospect, Substack was clearly interfering with my typing, causing delays between typing and text entry in the online document, as well as blatant omissions where words I typed simply were not recorded. I still have yet to hear back from support about these very obvious, glaring service errors.]


11/7: While I am writing [...] down [something] of consequence [on paper], [my] Apple [laptop] likes to go to "sleep" abruptly, much faster than it normally would.

11/8 at 4:50 pm: [The AI-brain interface] led me down [a] thought path I was too tired to manually pull out of. [I] didn't realize how it was going to [defame] me [at first]. [Right after] it did, [the] low rumble of the water heater began [to go off]. [In contrast to the fridges which only make noise,] the water heater has the additional [effect] of making the house vibrate slightly.


11/9: [I] was reading about FBI framing and entrapment, and [...] thought "that data goes to China" [... The] keyboard switches to Chinese (Simplified) without my noticing [any key inputs, which likely did not happen at all]. In all my time at the computer this year, I cannot remember that having happened once [inadvertently]. [Was this a] statistically significant coincidence [where I accidentally pressed the keys that would have resulted in precisely-timed keyboard language input switching], or is my computer doing [things] without any actions taken by me?

11/10 at 10:30 pm: [I am] working on [the] Bryan Kofron testimony [part of the article]. Without touching anything, [the] power suddenly cuts, shutting off monitor [and] computer. [I] plugged it back in and thankful nothing was lost.

11/10 (cont.): Earlier, Substack shut down [without cause] whereas this had *never* happened before. I lost about 20-30 minutes of work at "3:17:17 pm" [time recorded when I took a screenshot of the malfeasance]. [See screenshot of DNS attack on 11/10 at 3:17 pm:]



[It turns out that after careful analysis of the 50+ page paper, I had lost around a day's [worth] or more than 10 hours of work between this and other times where Substack has inexplicably malfunctioned and erased my progress. I was careful to save, and to observe that my content had been saved by looking for the *message which tells you your draft has been saved* in the top left corner of the screen ["Draft – Saved"]. So by Substack's own interface messages, something else had to have happened to cause me to lose *so much work*. Substack has yet to reply to my complaints about these atrocious errors on their platform. [I feel this is highly prejudicial treatment—bias informed by and linked to gangstalking—as I carefully explained what had happened and how their own platform had misled me in saying the content was already saved; there were also 7 unambiguous errors. See screenshot of receipt of complaint from 11/14/2023 that is still unanswered as of 12/1/2023:]




11/11: [I] clicked on a post about [a] third party [professional] gangstalker exposing defamation crimes—Twitter says "this post has been deleted"—but it hadn't. [I have] never seen this message before [though I have spent many hours on Twitter in the past year and a half]. 11/11 (cont.): [I] reviewed [the] section I worked on yesterday. Work in the Dr. John Hall section [was] erased—likely countless hours of work have been wiped in total across the document. [This is] atrocious interference with whistleblower testimony. I [absolutely] had reworked content from Dr. John Hall quotes that had obviously, *scandalously* been reverted to prior state of unworked, raw quotes. [Original copy I wrote was also lost.] [...] Looking further above, [I] notice other changes [that] had not been saved—though I saved the document dozens

of times yesterday and the webpage said everything had been saved[—]each time. This is the second time in 2 days I discovered Substack was *lying* to me about "saved" ["Draft — Saved"] changes and my content had been deleted.

11/11: [My] keyboard has been giving me static electricity regularly in past 2 days [that is to say it delivers electric shocks to my hands, something which had not happened since summer of 2021]—[how is it that I paid] \$150 for something that has such technical faults? 11/11 (cont.): [It] seems some of my edits in the intro[duction] were reversed as well, but [I] have not worked on it in over a week, so [I am] not [completely] sure. [Looking back in retrospect, progress on the introduction was definitely erased by Substack, likely dampening readership as this paragraph has an outsized impact on the impression of the article. The only paragraph in the 50+ page paper with serious problems was the second one from the beginning.] 11/13: [I] found more [areas where] progress [was] reverted [and] erased from [the] Trower testimony.

11/14: [I am] finding more unambiguous evidence that significant amounts of progress on the article were erased by Substack. Hours, [if not] a full day of progress [was] lost[.]

11/24: [I] discovered that not only has Substack erased my content, which the platform falsely said it had been saved ["Draft – Saved"], lagged while I was typing which resulted in obvious omissions from keyboard input, and not responded to my complaints, but it has also hidden the "restacks" of my article and arbitrarily changed the date back and forth from November 11th to November 12 and back again. This amounts to 7 "technical errors" which interfered with the publishing of my article that provides evidence of the targeting program. [See the below screenshot which shows Substack hid 2 " likes," as notifications clearly shows that 2 users in addition to 9 others liked the post, as well as one more later, but the post still only has 10 likes.]



11/29 at 6:20 pm: [I] discovered spelling errors and other changes in this [affidavit] have been erased, even though I have meticulously saved the document. The only possible explanation is hacking. I specifically remember fixing these typos and discovered today that my changes were somehow not saved. [See screenshot taken at 11/29 at 6:20 pm with spelling errors unchanged:]

10/28 (cont.) at 3:15 pm: Just heard "Branson kid" in addition to all the names from the school heard earlier during the day. Emotionally-loaded words tailor-made to discreit. This time, I could easily identify what had happened as a deserpate attack on my reputation—was working on [my] ebook evidence [...] consolidation. Very unambiguously would not have happened naturally, let alone under natural circumstances. [It would have represented a] clear break from [my] natural personality [had I not know where it comes from].

11/29 at 6:31 pm: As I go through the document, I notice more areas where I had certainly already made changes which I am having to go back and make again[.]

11/29 at 6:44 pm: The type of errors I am finding the document full of are specifically the type of errors I edited for the last time I worked on the document. There is absolutely no chance this happened without the interference of hacking. [I have never seen such errors in Microsoft Word.]

11/29 at 7:07 pm: I continue to notice unresolved errors of the exact type I edited the document for two days ago. Specifically, this includes where the journal entry I originally wrote did not start the sentence with a subject, and before I had gone and added "[I]" to correct the grammar, for example.

11/29 at 7:43 pm: [I] noticed another specific change that I had absolutely made before but had not gotten saved, despite my meticulously having saved the document countless times while working on it. I took a screenshot of where "interrogation" was missing the end quotation mark which I definitely fixed before. I have continued to notic[e] that the document is full of the same kind of obvious errors which I had already corrected before[.] [See screenshot taken at 7:43 pm:]

also used language that seemed about "FBI investigators" and "the word "interrogation to describe let him know I was not after him does not want to help, that is of our rights. Others have refused by reference to my RNM. However

11/29 at 10:11 pm: I just witnessed errors which I have never seen before in Microsoft Word. One and a half of the words I typed disappeared, while other changes I made also mysteriously disappeared seconds after I made them. My work on this document is blatantly being interfered with. I have also observed how the same errors which I corrected last time or two times I worked on this document have amounted to perhaps half a day's worth of lost work.

Vehicle sabotage:

10/21: [My] bike chain was derailed. [This] never happens in all the riding I have done. Somehow has occurred 3+ times while parked in front of the house. I got grease (dirty) on my hands while fixing it, and also hit my head on the handlebar while I was preoccupied by analyzing the [inexplicable] situation out loud. Today, I read the program creates situations in which you "do things to yourself," and this incident seemed to be related [to that aspect of targeting]. I think it may be creating situations in which you are more likely to make a mistake so as to avoid blame [for what happens to you.]

10. Effects on family and friends:

I believe nearly every aspect of my life has been synthetically influenced to create the desired conditions for this psyop. [...] Evidence of division of all kinds is abundantly clear. I am afraid of trying to make friends because I fear we will be divided somehow by something which is not natural.

11/29: I have moved around a lot and do not have any close friends anymore, especially post-pandemic (gangstalking began in early 2021 or earlier). Targeting has precluded social life, and actually made it so that I usually avoid people. I believe it was planned and ensured that I should not have people I can reach out to,

11. Effects on employment:

Gangstalking destroyed my economic opportunity by tarnishing my reputation and distributing misinformation about me. It took me two years to get a part-time job, the longest time I have been unemployed by far. While I am grateful for my current remote part-time job, the last store job I worked at Walmart was made exceedingly more difficult than it should have been because it exposed me to non-stop gangstalking. Customers and other employees constantly referenced information illegally gained by remote neural monitoring in order to slander me. I have not had another part-time job since I left that position due to the severity of gangstalking defamations.

12. Effect on finances:

Due to the impact on my employment, I accumulated over in debt and was

I had only been in debt once before in my life, and paid this nominal amount off

I am normally very responsible with my debt and believe this situation could only have occurred due to targeting.

13. Lawsuits filed:

I have joined the Targeted Justice, Inc. v. Garland (4:23-cv-01013) class action lawsuit filed in Houston District Court, S.D. Texas. I have also joined an international class action lawsuit filed by ICATOR against the Belgian Government (for not protecting rights in the European Union), which could go to the European Court of Human Rights and/or ICC.

14. Senators and Congressmen contacted:

I have contacted Sentors Steven Danes, John Tester, and Christopher Pope. I have also contacted members of Congress, including Ryan Zinke, Elise M. Stefanik, Gregory Steube, Chris Stewart, Kelly Armstrong, Steve Scalise, Dan Bishop, Darrell Issa, Thomas Massie, Tom Emmer, Mike Johnson, Kevin McCarthy, Kat Cammack, Matt Gaetz, Jim Jordan, and Jim Hamilton.

 Artificial predisposition to injury, strange physiological events, dream manipulation, other unprecedented medical events, and insomnia

10/17: [My] upper left eyelid twitches at times, resembling the twitching videos [I have] seen [from other Targeted Individuals]. In 2021, my lower quadricep also experienced this [for the first time, and my feet did as well-also seemingly for the first time]. Earlier in [summer] of this year, 2023, my lower back was twitching severely [which never happened before]. One night at the beginning of soccer season, my entire lower body spontaneously experienced a [violent] muscular convulsion, [a] severe tightening of all my [lower body] muscles while I was simply laying down. I was going to sleep. It was so severe, I felt like all the muscles in my legs were about to be torn [and I was very afraid to move, but knew I had to get into a different position to release the inexplicable tension]. Yet I was not making any sudden movements which could have remotely been the cause of this. After this incident, I got immediately injured every single [time] I played soccer. This too had never happened before, nothing close, [not] even remotely. I had to miss games to heal after each time I played until I pulled my hamstring in by far the worst sports injury that has ever happened to me. To be clear, every time I went to the field, I got a strain or tear in a new area. This attack had created predispositions to injury everywhere in my legs. I had never experienced getting injured so easily, let alone every time I went to the field. This all happened maybe 2 weeks after I got my TargtedJustice.com shirts and started tweeting about targeting. It ruined my entire season that I had paid \$100+ for and [had been] wait[ing] for since there was not the opportunity to play in a long time.

11/28 at 1:30 pm: [...] The handlers try to disrupt me many times at the very moment I am about to drift off to sleep[,] often [...] insert[ing] something defamatory that I cannot let go, right as I am about to drift off. I have no choice but to stop myself from falling asleep to affirm that I object to being framed in this way[.]

16. Tinnitus I have experienced:

10/28: [I] heard acute tinnitus while shutting down computer in [my] left ear. [It] changed from one type of static noise to another.

11/1 at 3:00 pm: [I experienced] ringing in [the] ears while listening to [a podcast] and working on [the evidence] paper.

11/2: [I] woke up at 4am, [and] had loud, blaring siren-like noise [in my ear,] as if artillery or the monolith on the moon in 2001: A Space Odyssey had gone off next to [my left ear which was ringing]. [...] There is no natural phenomenon that can replicate this noise[,] which can be compared to the monolith siren in that movie. It occurred only in the left ear this time, which was facing up as I lay.

11/5 at 5:41 pm: [I had] ringing in [the] right ear[,] [which] lasted about 20 seconds. [Obvious example of tinnitus.]

11/30 at 10:02: I had tinnitus in my right ear, which came as a high-pitched ringing sound.
11/30 at 11:55: [I] experienced tinnitus again in the right ear, seemingly in response to content I was viewing or things I was thinking about 5G.
